**4. New ASA website**

AcousticalSociety.org is now the official ASA website. It went live in early 2011.

**5. Membership**

Please look into whether you are eligible to become a Full Member. If you are a Full Member, you are eligible to vote and to hold office. After about 5 years as Associate Member you pay Full Member dues so you might as well become a Full Member. All you need is for two Full Members to sponsor you.

If you are a member of the ASA, you are eligible to serve a three-year term on the BA Technical Committee (BATC). The BATC is typically composed of individuals who are active in Society affairs but anyone may request to serve on the committee. The BATC terms start after the Spring meeting.

**6. New BA Chair**

An election was conducted in April, via email vote, by members of the BATC. BATC is a three-year term and there are about 80 members (<http://acosoc.org/TechComm/BATC/tcom/tcom.html>). The BA Chair Search Committee consisted of Mike Bailey, Carr Everbach, and Robin Cleveland.

Candidates were Franco Curra, Oliver Kripfgans and Bob McGough.

Bob McGough was elected as the new Chair and will begin his term in San Diego.

The voting method is now the same protocol as all but one other TC. An email vote facilitates the Chair transition and ensures a fairly robust voting pool of active BA members. Previously, a vote was conducted at the Spring meeting by whoever happened to be present at the evening BA TC meeting.

### AAAS Human Rights Survey

Mostafa Fatemi sat in on the AAAS focus group meeting as a representative of BA and updated the TC on what transpired.

The Wednesday night TC continues to be a success so we will keep the meeting on Wednesday at 8 pm.

### **8. Student Best Paper Poster Competition**

Seattle was the first time we have used a poster competition for Best Student Paper Award. The session was organized by Tyrone Porter, Todd Hay and Kevin Haworth and they did an excellent job pulling everything together. Attendance was quite good and the session ran well beyond the allotted 1 ½ hours. Three awards were given and the winners were:

Himanshu Shekhar (University of Rochester) "A coded excitation technique for the functional imaging of coronary atherosclerosis using ultrasound contrast agents."

3<sup>rd</sup> prize

Pavlos Anastasiadis (University of Hawaii) "Ultrasound-induced permeability variation in cell gap junctions for drug delivery."

The TC felt it was worth continuing the poster competition format at Spring meetings. Hong Kong would be the next meeting to have the competition but it was decided to postpone until Kansas City in Fall 2012 because student attendance in Hong Kong is uncertain and Hong Kong would be harder to organize.

Kevin Haworth emphasized that we really need members of the TC to volunteer as judges in order to make the poster format successful. The judges this year put in a big effort and more judges would have been very useful. Please consider volunteering in the future.

## **9. Student Council Report**

We need to select a new student representative whose term will begin at the Hong Kong meeting. The student representative serves over a two-year term. An email election will then be conducted before the San Diego meeting and the new rep will transition with the current rep in San Diego.

## **17. JASA Review Articles**

There is an effort to increase the number of review articles in JASA because it can help increase the impact factor of JASA in addition to being useful to the research community.

One means of doing this within BA would be to form a committee to identify some areas that would merit a review article and then identify potential authors. A token honorarium would be available to the author(s). Editor in Chief would need to provide the official invitation. Papers would be advertised.

Charlie Church indicated that Floyd Dunn has already agreed to write one such review article and Charlie is also willing to discuss your ideas for review articles with the Editor in Chief.

## **18. NIH Chairs**

Reviewers with ultrasound expertise are always needed for NIH reviews. It is important for ultrasound to have advocates at study sections because we are competing with other imaging modalities and reviewers who do not understand a proposal can doom it. learn more about the process. Talking to more-senior colleagues who have reviewed grants is also useful.

Larry Crum and Tyrone Porter stressed in Cancun how important it is to have strong ultrasound advocates on the study sections. It only takes one dissenting review to shoot down the chances of a proposal and it makes a huge difference for someone to correct misunderstandings. Sitting on study sections also gives you a perspective of where research trends are leading.
